



## GEDTS 2014 Series

---

### Score Range

*1/1/2014 - Current* A minimum score of 145 on each of the four tests in the battery AND a minimum total score of 580.

### Days to Complete

*1/1/2014 - Current* Testers are not required to complete all of the content areas in a specific time.

### Days to Pass

*1/1/2014 - Current* Testers are not required to pass the test in a specific time frame.

### Complete Before Retest

*1/1/2014 - Current* Testers are not required to achieve the status of complete before retesting on any content area.

### Days to Retest

*1/1/2014 - 5/24/2020* Testers are not required to wait for a specific period of time before retesting. After taking a content area 3 times, testers must wait 60 days before retesting.

*5/25/2020 - Current* For online proctored testing, testers are not required to wait for a specific period of time before retesting. After taking a content area 2 times, testers must wait 60 days before retesting.

*5/25/2020 - 12/31/2021* For in person testing, testers are not required to wait for a specific period of time before retesting. After taking a content area 3 times, testers must wait 60 days before retesting.

*1/1/2022 - Current* For in person testing, testers are not required to wait for a specific period of time before retesting. After taking a content area 3 times, testers must wait 60 days before retesting in the same calendar year.

### Max Retests

*1/1/2014 - Current* Testers are allowed to retest as many times as they want in a calendar year for each content area.

### Testing Languages

*1/1/2014 - Current* Testers are allowed to take the English test or the Spanish test.

### Combine Languages

*1/1/2014 - Current* Testers are allowed to combine the results from multiple languages to achieve a status of pass.

**ESL Required**

*1/1/2014 - Current*

Testers are not required to take the ESL test when they take the Spanish or French language versions of the test.

**Residency Required**

*1/1/2014 - Current*

Testers are not required to be a resident of the jurisdiction.

**Age to Test**

*1/1/2014 - Current*

Testers are eligible for testing when they are 17 years of age or older unless the tester is 16 years of age and has a jurisdictionally approved waiver of age.

**Age to Credential**

*1/1/2014 - Current*

Testers are eligible to receive the jurisdictional credential when they are 16 years of age or older.

# HiSET

---

## Score Range

1/1/2014 - Current

A minimum score of 8 on each test of the five tests in the battery AND a minimum essay score of 2 AND a minimum total score of 45.

## Days to Complete

1/1/2014 - Current

Testers are not required to complete all of the content areas in a specific time.

## Days to Pass

1/1/2014 - Current

Testers are not required to pass the test in a specific time frame.

## Complete Before Retest

1/1/2014 - Current

Testers are not required to achieve the status of complete before retesting on any content area.

## Days to Retest

1/1/2014 - Current

Testers are not required to wait for a specific period of time before retesting.

## Max Retests

1/1/2014 - Current

Testers are limited to 3 times per calendar year for each content area.

## Testing Languages

1/1/2014 - Current

Testers are allowed to take the English test or the Spanish test.

## Combine Languages

1/1/2014 - Current

Testers are allowed to combine the results from multiple languages to achieve a status of pass.

## ESL Required

1/1/2014 - Current

Testers are not required to take the ESL test when they take the Spanish or French language versions of the test.

## Residency Required

1/1/2014 - Current

Testers are not required to be a resident of the jurisdiction.

## Age to Test

1/1/2014 - Current

Testers are eligible for testing when they are 17 years of age or older unless the tester is 16 years of age and has a jurisdictionally approved waiver of age.

**Age to Credential**

*1/1/2014 - Current*

Testers are eligible to receive the jurisdictional credential when they are 16 years of age or older.

## Score Range

*1/1/2014 - 8/31/2020* A minimum score of 500 on each of the five tests in the battery AND a Pass essay score AND a minimum total score of 2,500.

## Days to Complete

*1/1/2014 - 8/31/2020* Testers are not required to complete all of the content areas in a specific time.

## Days to Pass

*1/1/2014 - 8/31/2020* Testers are not required to pass the test in a specific time frame.

## Complete Before Retest

*1/1/2014 - 8/31/2020* Testers are not required to achieve the status of complete before retesting on any content area.

## Days to Retest

*1/1/2014 - 8/31/2020* Testers are not required to wait for a specific period of time before retesting. After taking a content area 3 times, testers must wait 60 days before retesting.

## Max Retests

*1/1/2014 - 8/31/2020* Testers are allowed to retest as many times as they want in a calendar year for each content area.

## Testing Languages

*1/1/2014 - 8/31/2020* Testers are allowed to take the English test or the Spanish test.

## Combine Languages

## ESL Required

### Score Range

*1/1/2002 - 12/31/2013* A minimum score of 410 on each of the five tests in the battery AND a minimum total score of 2,250.

### Days to Complete

*1/1/2002 - 12/31/2013* Testers are not required to complete all of the content areas in a specific time.

### Days to Pass

*1/1/2002 - 12/31/2013* Testers are not required to pass the test in a specific time frame.

### Complete Before Retest

*1/1/2002 - 12/31/2013* Testers are not required to achieve the status of complete before retesting on any content area.

### Days to Retest

*1/1/2002 - 12/31/2013* Testers are not required to wait for a specific period of time before retesting.

### Max Retests

*1/1/2002 - 12/31/2013* Testers are limited to 3 times per calendar year for each content area.

### Testing Languages

*1/1/2002 - 12/31/2013* Testers are allowed to take the English, Spanish, or French test.

---

### Score Range

*1/1/1942 - 12/31/1993* A minimum score of 35 on each of the five tests in the battery AND an average score of 45. The average score is calculated by rounding down.

*1/1/1994 - 12/31/2001* A minimum score of 40 on each of the five tests in the battery AND an average score of 45. The average score is calculated by rounding down.

*1/1/2014 - Current*

TotalTranscript™ (TT) promotes parity between HSE and traditional K-12 pathways to high school completion by addressing the differential impact of mobility on HSE testers. In traditional K-12 pathways, schools universally honor mobile students' academic record, even when moving internationally. TT extends this principle to HSE and related alternative pathways. Specifically, TT honors mobile testers' academic record when moving between HSE test publishers. TT does so by generating a single transcript that integrates all current-series HSE test scores that adhere to JID test endorsement policies.
